CALENDAR STATEMENT

This course discusses care strategies for assisting diverse client groups such as clients with mental health diagnosis and clients with development delays and physical disabilities. Assisting with infant and child care will be discussed. Included in this course are modules that deal with understanding the disease process that causes both cognitive and physical decline in clients with a diagnosis of dementia. Skills and strategies relating to provision of care for clients with dementia will be identified.

GENERAL LEARNING OUTCOMES

Upon successful completion of this course, you will be able to meet or exceed the following:

- 1. Demonstrate best practice principles of infant care.
- 2. Integrate knowledge of human growth and development with care needs of children.
- 3. Examine personal feelings and experiences as they relate to aging and dementia care.
- 4. Examine normal changes in the brain and nervous system that occur with aging.
- 5. Examine causes and types of dementia.
- 6. Explore effective communication strategies to promote the helping relationship with clients diagnosed with dementia.
- 7. Examine strategies to create a safe environment for the client with a diagnosis of dementia living in a community or in a continuing-care facility.
- 8. Examine care strategies to provide individualized care to the client diagnosed with dementia.
- 9. Examine personal feelings and experiences as they relate to a mental health diagnosis.
- 10. Explain the impact of mental health disorders on society and families.
- 11. Examine the causes of mental health disorders and general signs and symptoms.
- 12. Integrate knowledge of human growth and development with the needs of clients with physical disabilities and developmental delays.
- 13. Examine end-of-life care and best practices while meeting care needs at the time of death.

Instructional Methods

- This course uses a variety of teaching/learning methods including: discussion, experiential exercises, learner presentations, role-plays, case studies, lectures, reflection, lab demonstration and practice, and group activities. These course activities provide the opportunity for learners to learn with and from others who are undergoing a similar learning experience.
- The course emphasizes pre-class preparation, participation in interactive classes, and post-class reflection and review. The learner is expected to take an active part in class

discussions and take responsibility for his/her own learning. The instructor's role is to facilitate learning.

Expectations of Students Writing On-Line Exams

- 1. Exams will be written in a computer lab at the college. The course instructor will provide information related to where the student is to write the quiz.
- 2. These are **not** open book exams. The quiz is to have been studied for prior to the quiz or exam date and is to be completed independently: that is by oneself, not in collaboration

with or in the company of another person or persons. No photos of quiz questions are to be taken via phones.

- 3. Final exam will be invigilated by the instructor. The time and place can be found in the course syllabi or timetable.
