☐ In Person

- 1. Requests for refunds for fees dated five (5) working days or more prior to scheduled service date will be granted, with \$25 of the fee retained by the College.
- 2. For cancellations dated less than five (5) working days prior to scheduled service date, no refunds will be granted. In exceptional circumstances, the Dean or Director of the program may overrule this policy. Rescheduling is treated as a cancellation.
- 3. Nonattendance of scheduled service is not notice of cancellation.
