

# **KEYANO COLLEGE SINGLE STUDENT RESIDENCE CODE OF CONDUCT**

#### **Single Student Residence Code of Conduct**

#### **Purpose**

To outline the standards of behaviour considered in line with the goals and the wellbeing of the residence community and to define the procedures to be followed when students and/or their guests fail to meet these standards of behaviour.

Every resident of the housing residences must accept that certain standards and rules need to exist in order for a large group of students to live together and function as a community within a relatively small environment.

These standards are based on the principles of **common courtesy, responsible freedom and respect.** 

None of the following will be accepted as an excuse /reason/ rationale for behaviour:

- Ignorance
- Anger
- Alcohol
- Substance abuse
- Physical or Verbal Abuse
- Theft
- Violence

#### Resident's Rights

- As per the Alberta Human Rights Act, all persons are equal in: dignity, rights and responsibilities without regards to race, religious beliefs, colour, gender, physical disability, mental disability, age, ancestry, place of origin, marital status, source of income, family status or sexual orientation;
- Treat with respect, civility, courtesy and consideration for all residents, Residence Life Staff, Keyano Security, and all other Keyano Staff;
- Take all actions possible to ensure safe and responsible actions are followed through;
- Respect the rights, privileges and privacy of your roommates, work with them cooperatively to keep the unit in a clean and tidy condition;
- Enjoy an atmosphere intended to refrain from behaviour which is reasonably interpreted as unwelcoming including but not limited to remarks, jokes or actions which demean another person and/or deny individuals their dignity and respect;
- Respect privacy of roommates or others (e.g. neighbours);
- Take appropriate measures to protect and ensure personal health, safety and wellbeing, including seeking help for issues of self-harm, self-abuse, eating disorders, suicide attempts, or negligence related to health, hygiene or medications.

#### **Discipline System**

Any resident that does not abide with the rules and regulations of the Code of Conduct will be disciplined accordingly. The disciplinary procedures include the following actions based on severity:

- 1. **Verbal Warning:** For behavior such as, excessive noise, littering, excessive messiness in residence units, etc. These warnings can be issued by any member of the Housing Department.
- 2. **Written Warning:** May be issued due to a specific incident when the seriousness of the incident warrants. These will be issued by the Residence Life Advisor and/or Housing Manager.
- 3. **Probation:** A resident placed on probation will remain on probation for the remainder of the academic year and for a period up to 12 months. Probationary status may be reviewed after six months upon written request by the student.
- 4. **Eviction:** Eviction may occur when a student violates the conditions and can be authorized by the Resident Life Advisors, Housing Manager, College Dean and/or Director.

#### **Evictions**

Evictions will be reviewed on a case by case scenario for each tenant. The Rental Agreement may be cancelled by a Residence Life Advisor at any time with valid reason. A resident, once evicted from Keyano College Residence, will not be accepted into residence during the subsequent year and are not welcome on any Keyano College Residence properties as a visitor or as a guest.

#### **Room Entry**

- A. Outside agencies, such as the telephone company, will be given access to enter your living area, and bedroom if necessary, to install or repair the equipment there. If you have any concerns about this contact the Housing Office.
- B. Law enforcement agencies will be permitted entry when a legal search warrant is presented. The Residence Life Advisor (or designate) and/or Security will be present.
- C. The College reserves the right to reasonable entry to student rooms to make necessary repairs, to maintain safety and health standards and to assure compliance with College rules, regulations and policies. The Facilities Department reserves the right to not complete necessary work orders should the residence (including appliances) be deemed unclean.

You can expect someone to enter your unit when:

- A. You have reported a maintenance problem.
- B. There is an obvious problem that must be dealt with by College staff.
- C. The staff member demonstrates a need to enter the unit to meet emergency situations, enforce rules, and for safety reasons.
- D. It is a scheduled residence inspection day.
- E. When a vacated room needs to be cleaned and/or repaired.

#### **Probation:**

For a 12 month period. Probationary status may be reviewed after 6 months upon written request of the student.

#### **Eviction:**

Evictions will be reviewed on case by case scenarios for each tenant. Loss of visitation privileges from residence for 12-month period. Loss of admittance to residence for a 12-month period.

If a single student returns after a 12-month period, student will be placed back in Clearwater Hall for a 4 month review. After the 4 month period the student can request for a room/unit transfer to Riedel at the cost of \$150.00 upon approval.

Appropriate action will be taken against the tenant for failure to report any incidents or breech in the code of conduct in any way.
